

Capital Punishment Should be Banned in the USA

The death penalty, or so-called capital punishment, maintains its role as one of the most disputable and controversial subjects within American society. If taking into consideration the fact that the current state of affairs concerning capital punishment is debatable due to the permissibility of its use in thirty-one states, it is apparent that other states have expressed direct opposition to the implementation of capital punishment. Since the vast majority of death penalties are heavily criticized in American society, it is evident that the regulation of the issue is required. Although it is widely considered that capital punishment is a conscionable method that serves primarily as a response to the most horrific crimes, its irreversible nature, inhumane character, and its low impact on crime rates are proving the reverse in a more rational and meaningful way.

Firstly, as for the irreversible character of capital punishment, it is apparent that this directive cannot be taken back. In other words, if further evidence of the case proves that the "perpetrator" conducted no measures in the crime, it would be impossible to return a person back to life. In turn, even life sentences can be canceled—meaning that it serves to be more beneficial and safe for people. The most remarkable piece of evidence is the case of Cameron Todd Willingham, who was executed in 2004 due to the assumptions of him setting a fire that killed his children (Possley, 2014). In fact, further investigation and evidence has proved that he was not affiliated with setting the fire; however, it was too late to direct the scenario in favor of Willingham. By depicting a single case, it is apparent that capital punishment includes high risks and the potential for mistakes that costs the lives of people, highlighting its barbarity and unjust nature. Subsequently, the act of capital punishment diminishes the structure of criminal justice, indicating the current potential for mistakes that are irreversible. Moreover, this particular aspect is linked to the characteristics of human behavior under the scope of capital punishment.

Secondly, the modern methods of the death penalty have proved to move far beyond the hangings and shootings in the US; however, they are still practiced in some parts of the world. The critical issue is that it would be desperate to discover an approach towards the death penalty that would not damage or harm any ethical or moral elements of common social order. In turn, the intended killing of another person, even in the form of lethal injection, is no more than the perpetual cycle that encourages violence to be the determinant of social order. Subsequently, violence under the scope of capital punishment should be examined as the most horrific and dangerous element of modern realities. The long search towards the discovery of an immediate, humane, and stable method for capital punishment has not scored any exceptional outcomes over the last few decades, indicating the existence of violence within each separate death penalty in the US. For instance, the case of Joseph Wood, who was a man that required approximately two hours to be executed in 2014, is crucial to realize that the system has not created any significant achievements or objectives (Marin, 2014). The absence of humane approaches makes the existence of capital punishment irrational and absurd, pointing out the necessity to regulate crime in more efficient ways.

Thirdly, capital punishment has demonstrated to have little-to-no effect on crime rates, indicating that the vast majority of criminals perceive capital punishment as a tool of fear, not as a real threat. In fact, most cases of capital punishment happen with the approval of the US Supreme Court—meaning that criminals should have paid more attention towards this matter. In turn, it would be incorrect to deny the fact that criminals do not fear capital punishment, which is crucial in the realization of anti-death penalty concepts of disseminating fear among criminal areas and communities. However, the results prove that most criminals perceive the death penalty as a temporary phenomenon that should be canceled shortly to reconsider the value of

each human being appropriately. The possible scenario for capital punishment to fall is to maintain continual attrition to the point when all capital punishment executions would disappear ("Capital Punishment Deserves a Quick Death," 2018). Consequently, the character of paying back debts under the banner of capital punishment is unrequested, since the modern world is not prepared for such unsightly directives and preferences of authorities.

Lastly, the issue of capital punishment was always one of the most debatable topics, as proper analysis was required. As a whole, the sociological and psychological explanations coupled with rational thinking are essential determinants for the abolishment of capital punishment. Since the proponents of capital punishment have fewer arguments and back-up argumentation, it would be worth it to put more effort towards the abolishment of this horrific crime against humanity. Subsequently, a ban of capital punishment would regulate its irreversible nature, inhumane character, and low impact on crime rates, which are primary concerns for the US to understand.
